Rick's Driver Ed., LLC, hereinafter referred to as "The Driving School" agrees to provide the applicant, hereinafter referred to as "The Student", 8 hours of "Behind the Wheel" practical driving instruction based on the Ohio Driver Training Curriculum and 8 hours of observation training for a total of 16 hours of in-car training. Prior to the start of the in-car training, The Student must have a valid permit and received a Certificate of Completion from completing an Ohio approved online driver education course.

State of Ohio rules require The Driving School to make available all training within 6 months from the date of the School Official's signature and receipt of payment.

If The Student fails to complete the in-car training sessions within 6 months, The Driving School is relieved of the aforementioned obligation thus voiding this agreement. If all training is not completed within the 6 months, a new Training agreement must be completed and training must start over.

FEES:

- 16 hrs. in-car training - \$400
- Return Check fee due to insufficient funds – \$25
- Cancellation fee (for in-car training) - \$25

Cancellation for a scheduled morning driving appointment must be made by 6 p.m. the day before.

Cancellation for a scheduled afternoon driving appointment must be made by 10 a.m. the day of.

Failure to cancel as noted above will result in a Cancellation fee.

A cancellation fee shall also apply should The Student fail to appear without previous notice (as noted above) for the scheduled driving time, not be prepared (i.e. – no permit or in violation of any permit restrictions), or clothing permeates with the odor of marijuana.

REFUND POLICY: If The Driving School or The Student cancels this agreement for any reason, a refund will be pro-rated at \$100 a day. If the cancellation occurs due to The Student being expelled from training, the refund will not apply to the day of expulsion. Expulsion would include, but not limited to; intentional destruction of property, blatant disrespect of the instructor and/or disruption of the training session, or the possession of any tobacco product, alcohol, or drug of abuse.

The Driving School shall furnish a Certificate of Completion to The Student who successfully completes the in-car training no less than five business days from the completion date. "Successful completion" is defined as The Student exercised a good-faith effort during the in-car training. The Driving School does not guarantee the issuance of a driver license to The Student.
